AMM RESOLUTIONS

OHBA has produced a 2013-2014 Resolutions Update package that is a [status report of the resolutions](#) approved at the September 23, 2013 OHBA Annual Meeting of Members in Niagara Falls. OHBA invites and encourages local associations to submit resolutions to the 2014 OHBA Annual Meeting of Members at 9:00 a.m. on Monday September 22nd at the Ottawa Convention Centre. **Please submit resolutions to OHBA by Friday, August 29th**, this will enable us to circulate the material to all local associations for their review in early September, prior to the OHBA AMM. Our 31 local associations have a voice in the policies and priorities of our organization. Please provide us with your input.

MINISTRY OF LABOUR ENFORCEMENT ACTIVITIES

The Ministry of Labour (MOL) released the 2014-2015 construction sector plan which establishes the MOL's enforcement focus for the year. The MOL is preparing for an enforcement blitz in July and August focused on two areas, the first focuses that safety equipment is in place, including: guardrails, scaffolds, and personal protective equipment. The second blitz focuses on fall protection. The [Ministry has also published tips](#) on how to prepare for a MOL blitz inspection.

The residential construction sector in Ontario has made significant improvements to health and safety in recent years. According to statistics from WSIB, the residential rate group has lowered its lost time injury rate over 40 per cent over the past four years on record.

SPECIES AT RISK IN ONTARIO

On June 27, 2014, the Species at Risk in Ontario (SARO) List (O. Reg. 230/08) was amended. These amendments resulted in the addition of three new endangered species to the SARO List (Mottled Duskywing, Riverine Clubtail, Eastern Small-footed Myotis (bat)), three new threatened species to the SARO List (Lilliput, Threehorn Wartyback, Bank Swallow), two new special concern species to the SARO List (Eastern Wood-Pewee, Wood Thrush), the change of one species on the SARO List from endangered to threatened (Pugnose Shiner) and the change of two species on the SARO List from threatened to special concern (Eastern Musk Turtle, Crooked-stem Aster). OHBA made a submission to the Ministry of Natural Resources in May supporting an amendment to O.Reg 242/08 in response to the additional species being added to the SARO list that support permit streamlining and transitional policies for these new species.
